ST. KITTS AND NEVIS **REGULATIONS FOR THE REPLACEMENT OF** **CERTIFICATE OF CITIZENSHIP**

The Government of St. Kitts and Nevis requests that the following regulations be followed and met for the replacement of Certificate of Citizenship. Kindly forward all certified copies of the requested documents to the Consulate General of St. Kitts & Nevis in Toronto.

- One (1) Affidavit outlining your how the Certificate of Citizenship was lost, with the Applicant's Name, Date of Birth, Place of Birth, and how and when Citizenship was obtained.
- Two (2) Passport size photographs (The size of the photographs is 1.77" x 1.38" (45mm x 35mm))
- An **\$EC 500.00** or **\$CAD 250.00** money order made payable to the Accountant General for the Application Fee.
- A **CAD\$86.00** money order made payable to the Consulate General of St. Kitts and Nevis for processing and courier fees to St. Kitts and Nevis.
- A prepaid self-addressed Canada Post or other Courier envelope if you are unable to collect the replaced Certificate of Citizenship from the Consulate General of St. Kitts and Nevis office.

Upon receipt of the documents Homeland Security will process and verify the submitted information a Replaced Certificate of Citizenship will be issued to the applicant. The requested documents outlined above should be sent to:
